Report of Talmakiwadi Co.operative Housing Society for the year 2021-2022

Dear Members,

The last General Body meeting of the members was held on 26th March, 2022 which way delayed due to the Covid lockdown. Activities till March 2022 were covered in the previous annual report. This report will cover the workings and activities of the society after March, 2022 till September, 2022.

At the outset, the Managing Committee would like to express heartfelt condolences to the bereaved families of those Members and residents who have lost their dear ones during this period.

WORKING:

<u>Covid:</u> There are news reports of various mutations of the Covid and reporting of few cases of Covid reported in the city of Mumbai we request the members and residents to be vigilant and maintain the same corona-appropriate behaviour and disciplined restrictions.

The Building Whatsapp Groups expanded its activities beyond Covid news. So information about leakages, overflowing of tanks, plaster falling off, help for members in any distress etc was passed on, so that action could be taken. The My Gate App was a great help too for continuous notification

We thank all the residents for the co-operation and look forward to continuation of similar vigilance in future.

Waste management and Cleanliness

As reported in the last annual report the garbage generated from the society far exceeds the capacity of the bins installed in the society. We have hence entered into an arrangement with Sunlight Environmental Solutions for disposal of the wet garbage generated from the society for Rs.19, 500/- per month.

We repeat our earnest request to residents:

- Segregate the dry and wet garbage before handing over the same to housekeeping staff
- The housekeeping staff visits all houses in the morning to collect the garbage. Please hand over the
 garbage bins to the staff. Residents are requested not to keep the garbage bins in the passage or
 common areas, specially overnight.
- Keeping the garbage bins or bags outside not only spoils the cleanliness of the building but also leads to rodent menace which the Society is presently encountering in the Society.
- Members who have let out their tenements on leave and license basis are requested to inform their tenants to ensure to maintain hygiene and cleanliness in the Society premises.
- Residents are also requested to inculcate habit in the children to maintain cleanliness and hygiene to ensure that there is "No Littering and No Spitting"
- Pet owners are requested to CLEAN UP immediately and they carry a Poop picker or Scooper or they carry Poop bags when they take their pet for a stroll.
- DO NOT THROW LITTER FROM WINDOWS.

<u>Security:</u> The quality of Security is a problem area that has been persisting. We have changed the security agency twice during the year and finally a new agency G9 has been appointed from 15 September 2022. Hopefully this agency should be good.

<u>Water Management</u> –. Residents are requested to inform the Society office of any water leakage as soon as such leakage is noticed so that immediate action can be taken.

Letting out residential premises on Leave & license by Tenant Members –

It has been observed that Members let out their tenements, and the subtenants insist on shifting immediately, without due documentation. This is not acceptable.

There are certain rules framed in the interest of ALL members and before getting into any dealing with brokers/ prospective subtenants, the concerned Members <u>must be</u> aware of the rules, which are available in the Society office

No sub tenant will be allowed to occupy the premises until the documentation is complied with. Violation of this condition will be taken as Trespass.

<u>Structural Repairs</u> – As informed in the previous General body, M/s SV Engineers was appointed to carry out the Structural Repairs and work commenced on 16thOctober 2021.

The decision was taken to undertake repairs in four steps: (Bldgs 1,1A&2) (Bldgs 3-5,4-6), (Bldgs 7,8 & 9) and finally (Bldgs 15 & 17).

Repairs and painting of Bldg nos 1, 1A and 2 have been completed. Repairs of Bldg 3-5 and 4-6 is complete and painting is in progress. Bldg 7, 8 and 9 repairs are in progress.

There has been some delay in the work being carried out initially due to labour shortage due to Covid and also due to heavy rains. Hopefully the speed will pick up.

Update on legal matters:

- Mirjankar Matter was last heard on 31/2/2022. New date to be informed.
- o Rohit Kulkarni vs Devdutt Kulkarni Society has admitted the nominee as Provisional member as per the revised MCS Act. We are hopeful that the family settlement is arrived at.
- Legal notices sent to Ms. Ranjani Mallapur, Mrs. Vanita Gangolli, Dr. Leena Gangolli and Ms. Anjali Gangolli for recovery of dues as decided in the previous AGM. There is also a family dispute case between Ms. Ranjani Mallapur and her relatives where society has been made a party. Hearing is scheduled for 12 September 2022
